While there may be many allegations made between parents, **The Therapeutic Solution** strives to provide a neutral, non-judgmental, and respectful environment for the parents who use our services. Our focus is on ensuring children can have safe and positive contact with their parents.

We have four playrooms at our center that are well stocked with toys and activities. Children of all ages and the visiting parents can choose from numerous activities.



Therapeutic Supervised Visitation

Therapeutic Supervised Visits are non-confidential. Therapist-patient privilege does not apply.

Goals of Therapeutic Supervised Visitation

- To provide a protected visitation and a therapeutic intervention between children and the non-custodial parent to help the parent develop the skills to provide a healthy parent in a healthy fashion so that the child benefits as much as possible from the contact.
- To assist children and their families in maintaining or re-establishing relationships that are healthy and safe for the child.
- To assist children in the transition to different family structures, while providing for the safety of the child.
- To provide custody evaluators and treatment professionals with supplemental information for visitation and treatment planning.
- To actively engage in assisting the non-custodial parent and child to re-engage in a relationship if it has been interrupted by the court process.

Services and Fees

The Therapeutic Solution offers a number of services to meet the various needs of the clients and courts we serve, including:

Monitored Exchange – per exchange	\$45
Late Fee	5 minutes or less \$5 6 – 10 minutes \$10 11 – 16 minutes \$15

Unless specific fee arrangements are noted in the court order, each party will be responsible for their intake fee. The visiting parent will be responsible for the cost of all visits. If not referred from the court or DFS, with the exception of Therapeutic Supervised Visitation, **The Therapeutic Solution** determines the level of supervision.
